Storage:	<p>Storage: Polypropylene shall be stored in enclosed dry space preventing from direct sun rays, on shelves or pallets at least 5 cm from the floor, and at least 1 m from heaters, at temperature max 30°C and relative humidity max 80%.</p> <p>Prior to processing, bags with polymer shall be kept for at least 12 hrs in production area.</p>
